- Sterile Yankauer suction handle.**
- Sterile and non-sterile extension sets for enteral feeding.**
- Sterile and non-sterile stoma EN-Plug.**
- Sterile enteral feeding tubes.**
- Sterile oral and enteral feeding syringe system.**
- Sterile bifurcated vaccination needle.**
- Sterile and non-sterile spinal syringe system (without needle).**
- This includes sterile and non sterile medical filters and catheter connectors.**
- Non-sterile introducer needle to guide the insertion and placement of a spinal/epidural needle**
- Sterile wound drainage systems.**
- Sterile Suction Catheters (open and closed) for removal of mucus within the respiratory tract**
- Enteral syringe driver for volume controlled enteral fluid delivery.**
